## Invitation to Membership

Upon acceptance of an application, and if there is a vacancy in the class of membership applied for, the Board of Directors shall invite the applicant to assume membership in the corporation. An invitee must accept the invitation to join in writing, within fifteen (15) days of the date of the invitation, and must pay dues prorated through that date upon acceptance. If a reply is not received within the fifteen (15) day period, the corporation shall automatically consider the invitation rejected. If the invitation is accepted, the Board of Directors shall invite the invitee to the next regular meeting of the corporation.

## Associate Member

Associate members shall consist of those members who are accepted for Associate membership, who timely pay dues set by the Board of Directors at the annual meeting of the Board of Directors and who attend a minimum of 50% of all meetings and functions of the corporation. Associate members shall have the privileges of Active members, except voting, holding office and costuming at the annual ball of the corporation. An Associate member may become an Active member only upon written request at the annual meeting of the membership. An Associate member may become an Active member, if a vacancy occurs in the Active membership, upon written request, in the order of said requests, at any regular meeting of the membership, in accordance with the by-laws of the corporation.

## Active Membership

Active membership shall consist of those members who are accepted for Active membership, who timely pay dues set by the Board of Directors at the annual meeting of the Board of Directors and who attend a minimum of 50% of all meetings and functions of the corporation. Active members shall have one (1) vote on each matter submitted to a vote of the membership. Active members shall be entitled to any office of the corporation, shall costume at the annual ball of the corporation and shall have the privilege of participation in all social, civic and beneficial affairs of the corporation.
